#### Photo Tips

Photographs are very important to your entry. We must be able to see your work, so take lots of photos and follow these tips:

- Take broad shots before, during and after the job.
- Take close-ups of detail work – prep and intricate color schemes.
- Do NOT send photos that reveal safety hazards.
- High resolution (300 DPI) photos on a CD or flash drive.

### Official Rules

To enter, follow the directions on this page. Eligible jobs must have been completed in 2009 by the painting contractor submitting the entry. Subcontracted work is prohibited. Entrants must be contractors engaged in architectural or industrial painting – not full-time decorators, interior designers or builders. Entrants must be at least 18 years of age. All entries must include a signed Official Entry Form. Winners will be selected by the staff of *American Painting Contractor (APC)*, whose decisions are final. Entries and photographs become the property of APC, and are not returnable. The winners will be notified by Feb. 15, 2010. No prize substitutions allowed. Applicable taxes are the responsibility of the winners.
